The security for the issue will be state Road Use Tax revenues. The intended repayment source is Mall & Highway 6 TIF revenues.

The repayment source is the City's debt service property tax levy, 12<sup>th</sup> Avenue TIF revenues and Mall & Highway 6 TIF revenues.
