- 6. 2500 HOLIDAY COURT
  - a) ORDINANCE NO. 2020-1017 An ordinance amending the Coralville Community Plan to reflect certain property generally known as 2500 Holiday Court, Coralville, Iowa to be designated High Density Residential Use in place of Commercial Use, for 3<sup>rd</sup> and final consideration.

<u>Note</u>: This will change the land use map for a property located at 2500 Holiday Court from Regional Commercial to High Density Residential.

#### 7. EAGLE BEND AT CLEAR CREEK

- a) ORDINANCE NO. 2020-1018 An ordinance amending the Coralville Zoning Ordinance, the same being Ordinance No. 664, as previously amended, rezoning certain property located within the corporate limits of the City of Coralville, Johnson County, Iowa and generally known as Eagle Bend at Clear Creek, from R-1, Single Family Residential District, to R-PUD 1, Residential Planned Unit Development One District, for 3<sup>rd</sup> and final consideration.
- **b)** Consider **resolution** approving the PUD-A Site Plan for Eagle Bend at Clear Creek, Coralville, Iowa.

<u>Note</u>: This will rezone the subject property from R-1, Single Family Residential District to R-PUD 1, Residential Planned Unit Development One District and approve a PUD-A Site Plan. The Preliminary Plat was approved on October 27, 2020.

a) Motion to amend Ordinance No. 2020-1019.

b) ORDINANCE NO. 2020-1019 An ordinance amending the Code of Ordinances of the City of Coralville, as previously amended, incorporating a chapter regarding unbiased policing, for 2<sup>nd</sup> consideration.

<u>Note</u>: This ordinance prohibits certain conduct from law enforcement, creates a Citizen's Community Policing Board, requires the Police Department collect data on contacts with the general public and outlines training requirements for the Coralville Police Department.

#### 9. E. 9<sup>TH</sup> STREET DUCT BANK

a) Consider resolution approving Supplemental Agreement No. 1 with HR Green, Inc. for lowa River Landing Public Improvements, 2019 – E. 9<sup>th</sup> Street Duct Bank.

**Note:** This Supplemental Agreement is for the design and construction phase services for the communications duct bank addition to the E. 9<sup>th</sup> Street Public Improvements and is not to exceed \$14,136.00.

<u>Note</u>: This ordinance sets the base value of property in the Coralville Urban Renewal Area located in Coral Ridge Commerce Park.

b) ORDINANCE NO. 2020-1015 An ordinance amending Ordinance Nos. 650, 679, 97-786, 2001-941, 2002-95, 2013-1007, 2015-1018, 2016-1020 and 2017-1016 providing that general property taxes levied and collected each year on all property located within the Mall and Highway 6 Urban Renewal Project Area in the City of Coralville, County of Johnson, State of Iowa, by and for the benefit of the State of Iowa, City of Coralville, County of Johnson, Iowa City Community School District, and other taxing districts, be paid to a special fund for payment of principal and interest on loans, monies advanced to and indebtedness, including bonds issued or to be issued, incurred by said City in connection with said Urban Renewal Redevelopment Project, for 3<sup>rd</sup> and final consideration.

<u>Note</u>: This ordinance the base value of property in the Mall and Highway 6 Urban Renewal Area located in Coral Galleria.
