a) ORDINANCE NO. 2021-1012 An ordinance amending Chapter 145 of the City of Coralville regarding the Housing Code, for 1st consideration.

Note: This ordinance replaces the reference to the "Building Department" to "Community Development Department"; requires new owners to apply for a new permit rather than use the one from the previous owner; have short-term rentals treated the same as other rental units; set up reinspection fees for rentals after 1st reinspection; and give property owners four years between inspections if they are ready, present and pass their initial inspection.
