8. URBAN RENEWAL AREAS

a) ORDINANCE NO. 2021-1013 An ordinance amending Ordinance Nos. 650, 679, 97-786, 2001-941, 2002-95, 2013-1007, 2015-1018, 2016-1020, 2017-1016 and 2020-1015 providing that general property taxes levied and collected each year on all property located within the Mall and Highway 6 Urban Renewal Project Area in the City of Coralville, County of Johnson, State of Iowa, by and for the benefit of the State of Iowa,

City of Coralville, County of Johnson, Iowa City Community School District, and other taxing districts, be paid to a special fund for payment of principal and interest on loans, monies advanced to and indebtedness, including bonds issued or to be issued, incurred by said City in connection with said Urban Renewal Redevelopment Project, for 3nd and final consideration.

<u>Note</u>: This ordinance the base value of property in the Mall and Highway 6 Urban Renewal Area for projects that have been constructed within the last year.

<u>Note</u>: This expands the number of voting precincts from seven to eight as a result of Coralville's population increasing to 22,318 residents in the 2020 Census, a motion to collapse the second and third reading for this meeting was approved at the 12/14/2021 Council Meeting.

10. 5TH AVENUE STORM SEWER PROJECT

The retainage due in 30 days is \$4,450.82.
