### 5. CONSERVATION EASEMENT AGREEMENT ~ PUBLIC HEARING

a) Public hearing on a proposed Conservation Easement Agreement with the Midwest Oversight Association for the Clear Creek Stream Bank Mitigation.

<u>Note</u>: This conservation easement is for Reach 1, Reach 3 and Becky Creek totaling an area of 42.58-acres for a one-time steward ship fee of \$18,000.00. This is a requirement of the Banking Instrument for the Clear Creek Stream Bank Mitigation.

**Note:** This is for the abatement portion of the development agreement for the 413 10<sup>th</sup> Avenue project.

### 7. URBAN RENEWAL AREAS

a) ORDINANCE NO. 2022-1014 An ordinance amending Ordinance Nos. 608, 707, 2001-942, 2006-1052, 2013-1009, 2014-1007, 2017-1017 and 2020-1014 providing that general property taxes levied and collected each year on all property located within the Coralville Urban Renewal Project Area in the City of Coralville, County of Johnson, State of Iowa, by and for the benefit of the State of Iowa, City of Coralville, County of Johnson, Iowa City Community School District, and other taxing districts, be paid to a special fund for payment of principal and interest on loans, monies advanced to and indebtedness, including bonds issued or to be issued, incurred by said City in connection with said Urban Renewal Redevelopment Project, for 3<sup>rd</sup> and final consideration.

**Note:** This ordinance sets the base value of 3 properties in the Coralville Urban Renewal Area (Oakdale) on Crosspark Road. They are the car wash, auto parts store and a multi-tenant building.

b) Ordinance No. 2022-1015 An ordinance amending Ordinance Nos. 651, 706, 96-749, 96-777, 2003-969, 2013-1008, 2014-1011, 2015-1017, 2016-1019 and 2017-1015 providing that General Property Taxes levied and collected each year on all property located within the 12<sup>th</sup> Avenue Urban Renewal Project Area in the City of Coralville, County of Johnson, State of Iowa, by and for the benefit of the State of Iowa, City of Coralville, County of Johnson, Iowa City Community School District and other Taxing Districts, be paid to a special fund for payment of principal and interest on loans, monies advanced to and indebtedness, including bonds issued or to be issued, incurred by said City in connection with said Urban Renewal Redevelopment Project for 3<sup>rd</sup> and final consideration.

<u>Note</u>: This ordinance sets the base value of the 413 10<sup>th</sup> Avenue project property in the 12<sup>th</sup> Avenue Urban Renewal Area.

#### 8. PARKING FEES

a) Ordinance No. 2022-1016 An Ordinance amending Parking Fees, for 1st consideration.

**Note:** This ordinance will raise parking fines to \$25.00 and if not paid in 30-days the fine will increase by \$5.00. The current \$10.00 parking fine has remained unchanged since at least 1999.

### 9. PENALTIES FOR REPEAT OFFENDERS

a) Ordinance No. 2022-1017 An Ordinance amending Chapter 50 of the Code of Ordinances of the City of Coralville regarding repeat offenders for nuisance abatement, for 1st consideration.

<u>Note</u>: This ordinance will set penalties for repeat offenders and allow the City to immediately abate nuisance properties if the same violation occurs again within 24-months.

### 10. CRANDIC RAILWAY COMPANY LAND LEASES

**a)** Consider **resolution** approving two land leases with the Cedar Rapids and Iowa City (CRANDIC) Railway Company.

<u>Note</u>: This is to approve two land leases. Land Lease Document 1016 is for public storm sewers located on CRANDIC property north of Highway 6 between Clear Creek and CRANDIC Park in Iowa City and Land Lease Document 1072 covers Stormwater Pump Station #6 located within CRANDIC property near the northwest corner of 71 2<sup>nd</sup> Street (Jiffy Lube).
