<u>Note</u>: This is for construction of a new forcemain from Brown Deer No. 4 Lift Station west along Oakdale Boulevard, through the 12th Avenue intersection to Oakdale Road, then to the west end on Oakdale Road connecting to the existing gravity trunk sewer. The public hearing will be March 19, 2024.
