<u>Note</u>: This is to amend the Fiscal Year 2024 Budget for revenues and expenditures. The public hearing will be May 28, 2024 and the Budget Amendment needs to be filed with the State by May 31, 2024.

#### 7. BONDS

a) Consider resolution authorizing and approving Loan Agreements, confirming the sale, providing for the issuance of General Obligation Bonds, Series 2024A, and providing for the levy of taxes to pay the same.

<u>Note</u>: This is for financing the 5<sup>th</sup> Street Improvements – 12<sup>th</sup> Avenue to 20<sup>th</sup> Avenue and refinancing bonds.

# 8. ADDENDUM TO AGREEMENT TO SERVE AS DISSEMINATION AGENT FOR SECONDARY MARKET DISCLOSURE

<u>Note</u>: This will allow Piper Sandler & Co. to provide secondary market disclosure dissemination services for the G.O. Corporate Purpose Bonds Series 2023A & B and G.O. Corporate Purpose Bonds Series 202

## 9. IOWA THRIVING COMMUNITY APPLICATION

**a)** Consider **resolution** of support for an Application to the Iowa Thriving Communities Program.

<u>Note</u>: This Iowa Economic Development Authority and Iowa Finance Authority program is to further incentivize targeted housing development to communities and neighborhoods that are supportive of development.

## 10. WORKFORCE TAX CREDIT

 a) Consider resolution approving an Option Agreement with IRL Parkview Investments, LLC.

<u>Note</u>: This option is for IRL Parkview Investments, L.L.C.to purchase the Lot 4, IRL Parkview Subdivision for the IRL Parkview III development for \$13.00/SF. This is necessary to qualify for a Workforce Housing Tax Credit.

b) Consider resolution of support of the Application of IRL Parkview Investments, L.L.C. for funding via the Workforce Housing Tax Credit Program and pledging City monies for the same.

**Note:** This grant is for IRL Parkview III in the Iowa River Landing District south of Von Maur with the City pledging in-kind support of \$1,000.00 per residential unit for up to 42 units.

#### 11. FIRE DEPARTMENT SHIFT FEE SCHEDULE

a) Consider resolution establishing compensation to be paid to designated members of the Coralville Fire Department pursuant to Section 35.04 of the Coralville Code of Ordinances (as amended).

<u>Note</u>: This creates a fee schedule to compensate Volunteer Members and Duty Officers who meet the instation department staffing requirements for one shift a week.

## 12. IOWA RIVER LANDING LICENSE AGREEMENT

 Consider resolution approving a Lease Termination Agreement with MVCD Enterprises, LLC (dba Funky Zebras Boutique of Coralville).

Note: This agreement terminates the lease for 920 E. 2<sup>nd</sup> Avenue, D111 as of May 19, 2024.
