<u>Note</u>: This will add a Development Agreement with rebates for the reconstruction and renovation of the former Iowa River Power Restaurant.

9. URBAN RENEWAL ORDINANCE

a) ORDINANCE NO. 2024-1007 An Ordinance amending Ordinance Nos. 650,679,97-786, 2001-941, 2002-95, 2005-1014,2013-1007,2015-1018, 2016-1020, 2017-1016,2020-1015 and 2021-1013 providing that general property taxes levied and collected each year on all property located within the Mall and Highway 6 Urban Renewal Project Area in the City of Coralville, County of Johnson, State of Iowa, by and for the benefit of the State of Iowa, City of Coralville, County of Johnson, Iowa City Community School District, and other taxing districts, be paid to a special fund for payment of principal and interest on Ioans, monies advanced to and indebtedness, including bonds issued or to be issued, incurred by said City in connection with said Urban Renewal Redevelopment Project, for 1st consideration.

Note: This ordinance will capture the base amount value of Lot 1, Royal Jas & Diva Subdivision and Lot 2, Jacobs Clear Creek Third Subdivision which had construction in 2023.

10. CHAPTER 40.10 - INTERFERENCE WITH STREETS AND USE OF BUILDINGS

a) ORDINANCE NO. 2024-1006 An ordinance amending Chapter 40.10 of the Code of Ordinances of the City of Coralville regarding blocking sidewalks; for 2nd consideration.

<u>Note</u>: This ordinance changes Section 40.10 to prohibit not only groups of people from blocking streets, sidewalks and use of buildings but adds individuals and/or storing materials on the sidewalks and streets.

11. WELMARK BLUE CROSS/BLUE SHIELD

a) Consider **resolution** accepting the quotation of Wellmark Blue Cross/Blue Shield to provide health insurance for the City's Employees.

Note: The City has received a quote for a 1.77% increase to it current premiums for calendar year 2025.

12. GOLF CART LEASE AGREEMENT - EXTENSION

a) Consider **resolution** approving an Agreement with Yamaha Motor Corporation at the Brown Deer Golf Course.

Note: This is a lease extension for 60 golf carts at the Brown Deer Golf Course which forgives the October 2024 through December 2025 lease and moves up the beginning date for the new lease so it covers the period of October 2024 through September 30, 2030 in exchange for replacing the entire fleet with new carts earlier. This is necessary because a flaw in the steel in the rear axels was discovered in the current fleet.
