# 5. CORALVILLE WEST PART FOUR, LOT 1 ~ PUBLIC HEARING

#### 8. URBAN RENEWAL ORDINANCE

a) ORDINANCE NO. 2024-1007 An Ordinance amending Ordinance Nos. 650,679,97-786, 2001-941, 2002-95, 2005-1014,2013-1007,2015-1018, 2016-1020, 2017-1016,2020-1015 and 2021-1013 providing that general property taxes levied and collected each year on all property located within the Mall and Highway 6 Urban Renewal Project Area in the City of Coralville, County of Johnson, State of Iowa, by and for the benefit of the State of Iowa, City of Coralville, County of Johnson, Iowa City Community School District, and other taxing districts, be paid to a special fund for payment of principal and interest on Ioans, monies advanced to and indebtedness, including bonds issued or to be issued, incurred by said City in connection with said Urban Renewal Redevelopment Project, for 3<sup>rd</sup> and final consideration.

<u>Note</u>: This ordinance will capture the base amount value of Lot 1, Royal Jas & Diva Subdivision and Lot 2, Jacobs Clear Creek Third Subdivision which had construction in 2023.

## 9. 5<sup>TH</sup> AVENUE NORTH END IMPROVEMENTS

**a)** Consider **resolution** setting the public hearing on the plans, specification, estimate of cost and form of contract for the 5<sup>th</sup> Avenue North End Improvements.

<u>Note</u>: This is for the construction of a new hammerhead turnaround and drainage improvements at the north end of 5<sup>th</sup> Avenue. The public hearing will be November 12, 2024.

# 10. WELL 16 IMPROVEMENTS - ENVIRONMENTAL INFORMATION DOCUMENT

**a)** Consider **resolution** resetting a public hearing on an Environmental Information Document; and direct published notice of same, both for the Well 16 Improvements.

<u>Note</u>: A public hearing needs to be rescheduled for the Well 16 Improvements Environmental Information Document, which is a requirement to receive State Revolving Funds. The public hearing will be held on November 26, 2024.

# 11. TECHNICAL SERVICES PROPOSAL

**a)** Consider **resolution** approving a Technical Services Proposal with the East Central Iowa Council of Governments (ECICOG) for City Council Goal Setting.

<u>Note</u>: This proposal is for technical services for an upcoming Goal Setting Session of the Coralville City Council and is not to exceed \$6,000,00.

## 12. GOLF CART GPS SYSTEM

a) Consider resolution setting a public hearing for the proposal to enter into a Lease Agreement with Yamaha Motor Corporation for a new GPS System for Golf Carts at the Brown Deer Golf Course.

<u>Note</u>: This GPS System features the ability to control golf carts by being able to shut them off along with cart tracking from the clubhouse, ability to send messages to the user and ability to have advertising messages for each hole. The public hearing will be on November 12, 2024.

#### 13. COMPACT TRACK LOADER/SKID STEER LEASE

**a)** Consider **resolution** setting a public hearing for leasing a Compact Track Loader/Skid Steer with a mulching head for the Parks Department.

<u>Note</u>: This piece of equipment will be used by the Forestry program for timber stand improvement work and to keep invasives under control in Coralville woodlands and it will be used to maintain flood berms, some of the stormwater bio cells, the Clear Creek Stream Mitigation project along with snow removal operations and other project work. The public hearing will be on November 12, 2024.

## 14. OPERATING FOOD AND BEVERAGE AGREEMENT AMENDMENT

a) Consider **resolution** approving Amendment No. 1 to the Food and Beverage Agreement at Brown Deer Golf Club with Beer Makers.

<u>Note</u>: This extension of the Brown Deer Golf Club Food and Beverage Agreement is for the period of January 1, 2025 to February 28, 2026.

## 15. INTERMODAL ACCESS CONTROL EQUIPMENT

**a)** Consider **resolution** approving an Agreement with Parking, Inc. for the Intermodal Parking Equipment Project.

<u>Note</u>: This project is for replacing and updating the access control equipment and cameras at the Intermodal so they are fully compatible with the existing access control equipment used in other City parking facilities in the Iowa River Landing. This proposal from Parking Inc. is for new parking access equipment and installation and is not to exceed \$93,852.00.

**b)** Consider **resolution** approving an Agreement with Gerard Electric for the Intermodal Parking Equipment Project.

Note: This proposal from Gerad Electric is for the project cabling and is not to exceed \$5,979.00.

**c)** Consider **resolution** approving an Agreement with A Tech Freeman Security for the Intermodal Parking Equipment Project.

**Note:** This proposal from A Tech Freeman is for the project monitoring cameras and is not to exceed \$9,536.64.

#### 17. TARGETED GOAT GRAZING

a) Consider resolution permitting targeted goat grazing at 2873 North Liberty Road NE.

<u>Note</u>: The RoyAn Ridge Farm will be responsible to maintain the area and take care of the goats. The goats would take 9-15 days for the goats to complete their job. They Council can grant authorization to allow split-hoofed grazing livestock within the corporate limits for this purpose per City Code Section 55.12.
