7. **WELLS 9 & 10 STANDBY GENERATOR IMPROVEMENTS ~ PUBLIC HEARING**
 - a) Public hearing on the plans, specifications, estimate of cost and form of contract all for the Wells 9 & 10 Standby Generator Improvements.
 - b) Consider **resolution** approving the plans, specifications, estimate of cost and form of contract; ordering bids; setting a date for the receiving of bids; and directing posting of the bid letting; all for the Well 9 & 10 Standby Generator Improvements.

Note: This is for replacing the existing standby generator and automatic transfer switch located at the northeast corner of Holiday Road and 12th Avenue that provides emergency power for Wells 9 & 10 and to install a new variable frequency drive for Well 10. Bids will be due on February 18, 2025.

8. IOWA RIVER LANDING PROPERTIES ~ PUBLIC HEARING

- a) Public hearing on a proposal to dispose of an interest in real property, that property legally described as Lot 3, IRL Parkview, Plat 3.
- b) Consider **resolution** approving the disposal of Lot 3, IRL Parkview, Plat 3, Coralville, Iowa

Note: The city will enter into a proposed agreement whereby IRL Parkview will purchase the property from the City for \$13 per Sq. Ft. or a total of \$474,240.00 in exchange for constructing a multi-family residential project as approved in the PUD-B Site Plan for the property.

- c) Consider **resolution** approving an Option Agreement with TM Development, LLC.

Note: TM Development, LLC wants to enter into an Option Agreement with the City for Lot 4, Iowa River Landing Part Two located north of the West Parking Ramp in order to design a concept to be constructed on the property.

- c) **ORDINANCE NO. 2025-1002** An ordinance amending the Code of Ordinances of the City of Coralville (2011), as previously amended, making changes to Chapter 165, The Coralville Zoning Code, for **1st consideration**.

Note: These amendment to the Coralville Zoning code are based on observed needs by the Community Development Director in consultation with various staff members to better facilitate and direct positive development and redevelopment in Coralville.

11. WELL 16 UTILITY POTHOLING

- a) Approve Pay Estimate #2 FINAL to **Dave Schmitt Construction, Inc.** for Well 16 Potholing: \$0.00.
- b) Consider **resolution** accepting the Well 16 Potholing as completed.

Note: This project hydro-excavated potholes in order to identify the location of existing underground utilities for the Well 16 raw water main route from Timber Land over to and along 12th Avenue from Oakdale Boulevard to near Liberty Lane. The \$3,813.10 retainage is due in 30 days.

12. YOUTH SPORTS PARK IMPROVEMENTS

- a) Consider **resolution** setting a date of consultation and a date for a public hearing on the proposed Amendment No. 12 to the amended and restated Urban Renewal Plan for the Coralville Urban Renewal Area.

Note: This amendment will add the Coralville Youth Sports Park Improvements project to the Urban Renewal Plan for the Coralville Urban Renewal Area. This engineer's estimate for this project is \$1,800,000.00. The consultation will be February 10, 2025 and the public hearing will be February 25, 2025.

13. FUTURE FOREVERGREEN ROAD AND JASPER AVENUE ROUNDABOUT - SETTLEMENT AND 28E AGREEMENTS

- a) Consider **resolution** approving a Settlement Agreement and various 28E Agreements with the City of Tiffin and City of North Liberty; and various miscellaneous Agreements regarding the future roundabout at Forevergreen Road and Jasper Avenue.

Note: These various agreements will settle a longstanding dispute between the cities of Coralville, North Liberty and Tiffin regarding the intersection of Forevergreen Road and Jasper Avenue on the west side of I-380. Some of the agreements are for the construction of a roundabout at that intersection by Tiffin and North Liberty and the future construction of Jasper Avenue NW south of the proposed roundabout and Anderson Drive which leads to Pinseekers by Coralville.

- b) Consider **resolution** of intent to dispose of an interest in real property generally located west of and adjacent to Jasper Avenue NW and Forevergreen Road.

Note: As part of the settlement agreement the City of Coralville agreed to convey the portion of property it acquired from the Ruth E. Rarick Trust back to the Trust in order to facilitate the construction of the Forevergreen Road and Jasper Avenue Roundabout, which requires a public hearing. The public hearing will be February 11, 2025.

14. FUGITIVE TASK FORCE OFFICER MEMORANDUM OF UNDERSTANDING

- a) Consider **resolution** approving a Memorandum of Understanding between the Coralville Police Department and the United States Marshals Service for a part-time Fugitive Task Force Officer.

Note: This Memorandum of Understanding outlines a cooperative effort to assist in apprehending violent offenders and fugitives. Under the program, a Coralville Police Department employee will serve in an as-available capacity, assisting US Marshals in their efforts to arrest suspects, including those with nationwide warrants in exchange for overtime reimbursement and access to Federal resources which will greatly enhance the department's ability to pursue and apprehend offenders.
